#### 1. BACKGROUND INFORMATION

The project is funded by the Global Community Engagement and Resilience Fund (GCERF). It is implemented by Edutask Institute in partnership with Syri i Vizionit (SiV) and NGO Aktiv.

The project aims to promote and foster social cohesion, inter-ethnic and inter-religious co-existence, and opportunities for mutual exchange, by increasing awareness within local communities on PVE, enhancing educational, cultural and employment opportunities and increasing inter-religious and interethnic exchange. Furthermore, it will establish nine community centres with the purpose of offering a diverse range of services, particularly focusing on enhancing the capacities and skills of youth and women for employment opportunities.

The Edutask Institute is inviting applications from trainers to conduct training sessions aimed at empowering women and youth within a specified field. Interested trainers are given the flexibility to apply for leading specific training sessions, with the option ranging from a single session to multiple selections. This initiative is part of the project Activity no. OTPB-2.021, and here's a structured approach to fulfill the project's requirements:









## 2. OBJECTIVE

The main objectives the trainings are to:

- Equip youth and women with the most current, market-relevant skills sought after by employers, with an emphasis on both technical and soft skills.
- Foster socio-economic empowerment for youth and women by supplying them with essential tools
  and knowledge to either join the workforce or embark on their own entrepreneurial ventures.

#### 3. METHODOLOGY

The training sessions will be held in two municipalities, South Mitrovica and Viti, and are scheduled to occur on either weekdays or weekends, based on coordination with the field officer. The training program/curriculum has been determined by the project team as follows:

- Navigating your future: Career orientation and exploration
- Building Entrepreneurship Skills
- Digitalization
- Media Literacy and Critical Thinking
- Intercultural dialogue and PVE (Preventing Violent Extremism)

Trainers will receive a curriculum/instructional handbook, which they are expected to follow closely during the training sessions. Furthermore, a preparatory training session will be organized for all selected trainers. This is to ensure that they are thoroughly prepared and equipped to conduct the training sessions effectively.

#### 4. SCOPE OF WORK

Within the framework of these Terms of Reference, the contractor selected for this engagement is required to deliver services in accordance with the highest standards of professional and ethical competence and integrity.
